### **ASSOCIATE MEMBERSHIP:**

This membership classification is open to prospective members who maintain an active NCGA or PWGA membership with another club (and therefore will maintain an established index).

Associate members:

- Will not be added to the NCGA roster as part of the SoCo Peppers Golf Club;
- Will not be eligible to compete/apply for NCGA tournaments through the SoCo Peppers Golf Club; and
- May not be eligible for NCGA benefits that are available to Regular members of the SoCo Peppers Golf Club.

## MEMBERSHIP PRIVILEGES AND BENEFITS

SoCo Peppers Golf Club membership provides the opportunity to participate and compete in:

- Two-day Club Championship / Net Flight Championships tournament
- Clark McEnnis Memorial Match Play Championship (rounds/match results due dates are scheduled throughout the club's season).
- Scramble tournament and awards held at the end of the season.
- Certain SoCo Peppers golf tournaments will include the opportunity for Regular Members to qualify for NCGA events, including:
  - Associate Club Four-Ball Net Championship (Two-Person Better Ball)
  - Associate Club Championship (Best Two Balls of Four)
  - Associate Club Net Amateur Championship
  - Senior Four-Ball Net Championship (Two-Person Better Ball)

## MEMBERSHIP CATEGORIES

**Regular Members** are those over 18 who can participate in all club events as prescribed in the club Bylaws.

**Associate Members** are those over 18 who maintain an active NCGA or PWGA membership with another club (and therefore an established USGA index). Associate members can participate in all club events, but cannot enter NCGA qualifying events, as prescribed in the club Bylaws.

**Junior Members** are those under 18 who receive NCGA status but are permitted to participate in club events as guests only. Contact a Board Member for additional details on Junior Memberships.
